As I am drafting this article the volunteer signup sheet for it is sitting next to me and starting to fill up. My faith in our American Legion Family is that there will be an abundance of help, as each year the volunteers come together to make this event successful year after year.

Here we are in the beginning of February with a much-needed warm streak of weather and we are already off to a busy year. We hosted the County Council meeting in January. As a member of the American Legion Family, did you know that you belong to the largest Veteran Advocate organization in the country? What does that mean? The legion membership brings influence to protect and provide for veterans nationwide. Our voice is a loud one for the legal battles that fight for Veteran rights by Legion MN Dept. and Legion National.

In the past few years, the American Legion Department of MN has prioritized legislation for:

- Veterans Omnibus Bill
- Veterans Home Campus Revitalization
- MVDA Funding for Veteran Suicide
- Amended the Post 9/11 Service Bonus
- Property Tax Exemption for Gold Star Families

And currently the Legion Department of Minnesota is taking a stand against Governor Walz's attempt to reverse E tabs and attempting to implement major tax increases on proceeds that support legion posts across Minnesota. His changes will be a detriment to food shelves, Children & Youth programs, Veterans families, Veteran homeless shelters, fire stations, city festivals, 4th of July displays and much more. This would eliminate \$33M in charitable giving and \$35M in wages. *This one benefit alone is the line that the American Legion must hold*.

We attended the 6th District Mid-Winter Conference in Ironton, MN. I'm confident that we brought back lots of information as we always do. We are always looking for ways to improve our mission in serving veterans as an American Legion Post, and this is a perfect place to gain knowledge.

Your post has been well represented at conferences by Post and Auxiliary members. So much to learn and so many people with years of experience to meet. If you are ever in Ironton, stop at the legion and try the meatloaf, it is good!

To recap; We need fish fry volunteers, and the SAL is having a luncheon meeting on 3/25/23. Lunch will be served at 1PM and the meeting will start at 2PM. All members are urged to attend as we plan out the upcoming year and some awesome events this summer.

Those of us that are motorcycle enthusiasts are ready for some handlebars in the wind or knees in the breeze. It won't be long, that's for sure.

In 2022, District 6 Past Presidents Parley presented a challenge to all Units in the District to make quilts for the new Veterans Homes under construction. With scheduled openings in the fall of 2023, the hope was to have quilts for the first 10-20 veterans entering the facilities. It is the hope that this will be an ongoing project to provide all the veteran residents a quilt.

I approached my friend, Barb who is a quilter, to get some information on how to make a quilt. Upon hearing the "why" I was asking questions, she volunteered to make some for us. Shortly thereafter, she called to say her quilt group "Quilt Divas" was very interested in also contributing quilts for veterans. I shared this information at a meeting and it was well received. Our own member, Laurie Tonsager is making a quilt and Roberta Takle's friend, Phyllis is donating four. Quilt Divas have 5 totally completed, have 7 completed tops to be quilted and more in the works.

"Serving our Veterans" is one of our Auxiliary missions. Unit 112 members accepted the challenge and stepped out to our community where we found tremendous respect and support for veterans as well.

If there are quilters reading this and would like to contribute to this worthy project, the quilts need to measure 70" x 90", be washable and in colors of red, white and blue. They can be quilted or hand tied. The "Quilt Unveiling" will be at the May 4th meeting at which time all the quilters will join us to share their work. Veteran Spotlight



Jerome (Jerry) Takle is farm kid born in Walnut Grove, MN and went to school in Westbrook, MN. He would not confirm if he knew anyone from

"The Little House on the Prairie". His wife Roberta grew up near Windom, MN and they met at area 4-H events. After graduating high school in 1957 he went to the School of Mines in Rapid City, SD for Electrical Engineering and was in ROTC graduating in 1964. He was then commissioned into the Army as an engineer officer and went to Ft. Belvoir for branch training. He and Roberta were married in 1962. Jerry learned he was to be stationed in Germany. They planned to spend a few years stationed there dancing the polka at Octoberfest, building bridges over the Rhine River and whatever else the 11th Engineer group was assigned to do. That all changed when the army needed Engineer Officers in Viet Nam. So Roberta went back home and Jerry went to Viet Nam in 1966 with the 1st Engineer Group. They cleared mine field and roads and built Bailey Bridges. He returned home in 1968 and was in the Army reserve for a few years.

He then started a career as an electrical engineer for Rural Cooperative Electric Association in Elk River and joined the American Legion. When he joined Post 112 there were still 13 WWI veteran members. He has had many positions with the Legion. He was the post commander in 1973, the adjutant from 1983-2013, and in the Honor Guard. In those days the adjutant was also the membership guy and did the newsletter too. At the time there were over 500 members in the post. He has also been the Adjutant and Finance Officer at the District. And he has been the County Council Adjutant for 30 years.

He recalls events like Sunday brat feeds, County Council social gatherings, Memorial Day celebrations and the start of the Honor Guard in 1986 or 87. There were around 30 Members of the newly formed Honor Guard divided into 4 squads. Ed Norell was the post commander, Bill Dollansky was the honor Guard Director and Tony Belanger was the Sgt. in charge of drill and ceremonies.

Roberta was busy too. She graduated with a math degree from Hamline, worked for a credit union, the high school, was on the school board and was active in her church as well as the legion auxiliary while raising 2 kids.

How do we begin to thank people who have done so much for so long?

Jerry says he would like to echo what Lloyd Ricker past Department Commander said at a recent County Council meeting, "We need to get some new people involved that have a passion for the American Legion to carry on our work".

We're glad to have them with us.










Transformation of the old coat closet has been completed and now honors veterans from Desert Storm and Afghanistan.
