

VETERANS SPOTLIGHT

My parents left the former Yugoslavia in May of 1945 as communists were taking over the country. They met and married in a displaced persons camp in Spittal, Austria on January 20th, 1948. I was born precisely nine months later October 20th, 1948.

In June of 1949 the three of us traveled from southern Austria by train to northern Germany,

Bremerhaven, where we boarded The US troop ship USS Marine Jumper and sailed to New York

City -- Ellis Island. After being approved for entry to the United States we traveled by train from

New York City through Chicago and Minneapolis to Elk River MN where we were greeted By Wally Mattock who upon learning that we did not speak English called Father Joseph Trobec. As a parishioner of Saint Andrews, he knew that Fr. Trobec was multilingual. The pastor was born and grew up in the same area as my mother and they were distantly related by blood and marriage. Our sponsor who had guaranteed our family a place to stay and my father work at the recently closed Elk River Box Factory.

After a short stay at the rectory, we were housed by the Moos family in Nowthen for a few months prior to renting one of the units in a triplex situated where the department of motor vehicles is now. In April of 1952 we purchased a house precisely 2 blocks east the DMV where my youngest brother presently resides.

After arriving in the US our parent's added six children to our family; one on every even numbered year from 1950 until 1960.

As I spoke only Slovenian, my parents enrolled me in kindergarten at Saint Andrews elementary school at the age of 4 in hopes that I learn the English language which is commonly spoken.

A significant event in my life was catching the polio virus in June following my kindergarten year as being a patient at Sister Kenney with only English speakers for six weeks advanced my knowledge of the English considerably.

After completing elementary school, I spent two years at Crosier Catholic seminary in Onamia Minnesota. I completed my high school education at Elk River high school where I played football, basketball and ran the 100-yard and 220-yard dashes. I worked at Anderson bakery and Joe's Superette during my senior year. Five weeks after high school graduation I joined the US army on July 18th, 1966. I had basic training at Fort Leonard Wood then spent nine months in electronic school in Fort Monmouth NJ just outside New York City followed by a 2-year stint at a microwave radio site on a hill above the castle in Heidelberg Germany.

A second significant event in my life, after joining the service, was the loss of our father who died of a heart attack at work in January of 1967.

Immediately upon returning to the United States in July of 1969 I joined the American Legion and have been a member since.

Joe Pallansch offered me a job at UPA shortly after my return to the US and I worked there for six months prior to attending college with assistance from the GI Bill per my plan. I continued to work at UPA summers and autumns until I completed my studies at St. Cloud State College and received my engineering degree. I also worked week ends at Joe's Superette to assist with the family expenses.

Upon graduating in June of 1974. I made my first trip south of the Mason Dixon line with a fellow graduate followed by a six-week trip to the former Yugoslavia with my mother to visit family she had not seen for 30 years, and I had never met.

After returning from Europe, I entered the air pollution control as a field engineer for a Louisville KY company and worked for two years after which I took early retirement for two and a half years at age 28. I traveled around Europe visiting relatives, living in France, hitchhiking through much of eastern Communist Europe; finally returning to the US. I continued to work in the air pollution control field for a Pittsburgh company for 15 years working in many states and foreign countries including Brazil, India, Korea, and Columbia. After the Pittsburgh Company included me in a large "reduction of force", I found work with a Baltimore company where I worked for a decade before the company declared bankruptcy. Having lost two jobs through no fault of my own, I decided to become an independent contractor thereby being hired and fired on my own recognizance.

I met Mary McDevitt, the love of my life, at a school board meeting and then saw her again in the Legion after an auxiliary meeting over which she presided as president. At the time I was working in Jamaica, so we dated for two years before I proposed during our first trip together to Slovenia at the chapel in my father's village of 10 houses IG. We each pulled the rope and rang the chapel bell to announce our engagement. We married February 18th of 1995 and our twins, Malie, and Rafael, arrived June 12th of 1998. We temporarily sheltered in the house Mary owned kitty corner from the Dairy Queen before we built our new home on 45 acres purchased in the early 80s. We moved in in June 2002.

Over the years my work as a field engineer commissioning air pollution control projects has taken me to most of the most populous countries in the world including China, India, Indonesia, Romania and Russia. I have enjoyed the work and continue to work.

We have been fortunate as both Mary, a Speech Pathologist and I have science/math-based professions. Our professions are still in demand, and we continue to work into our 70s. I am working part-time while Mary is zooming her students around the country. As the flexibility of zooming allows Mary to work anywhere in the world where there is an internet connection, she has accompanied me on projects to Baltimore, Portland Oregon, and New Orleans in recent years. She even continued work during our holidays in Slovenia in February of 2023.

We are fortunate that we and our family has remained healthy. Our daughter Malie has completed her undergraduate degree in Speech Pathology at the University of Arizona and our son is studying to be an electrician at Dunwoody.

We will continue traveling as we drift from semiretirement into retirement. We spent Christmas in Costa Rica with our children and are presently wintering in California and Arizona with a couple visit with our daughter.

In April my wife is to take me on a cruise from New York to Europe, 75 years after my mother brought me from Europe to New York.


